The Directors present their Report together with the Half Year Consolidated Financial Report of the consolidated entity, being Lend Lease Corporation Limited and its subsidiaries ('Lend Lease'), for the six months ended 31 December 2007 and the Auditor's Report thereon.

2. Review of Operations and Consolidated Results

A review of operations is included in the Management Discussion and Analysis of Financial Condition and Results of Operations (MD&A) section of the Half Year Consolidated Financial Report.

For the six months to 31 December 2007, Lend Lease reported a profit after tax of A\$259.6 million as compared to the profit after tax for the six months ended 31 December 2006 of A\$174.7 million.

A 40% franked interim dividend of A\$172.5 million (December 2006: A\$140.0 million, 50% franked) has been approved by the Directors. The interim dividend of 43 cents per share will be paid on 26 March 2008 (December 2006: 35 cents per share paid on 27 March 2007).
